2. Client Acknowledgments

The Client acknowledges that:

- (a) The photographs, reproductions, electronic files, negatives and all rights in the photographs, reproductions, electronic files and negatives are Tanya sole property.
- (b) Tanya has the full and free right to deal with the photographs, reproductions, electronic files, negatives in any manner and for any purpose whatsoever.
- (c) All exposures of the photographs taken are at Tanya \square s discretion and which, in Tanya \square s opinion, best suit the day.
- (d) The number of photographs taken by Tanya will be at her sole discretion but will be the maximum of her ability on the date of provision of the Services.
- (e) The location/s for the provision of the Services have been discussed and agreed upon.
- (f) All decisions on the preference of colour and black and white are at the discretion of Tanya.
- (g) It has discussed the style of photographs that Tanya offers and confirms it is happy with the style of photographs Tanya offers.

3. Payment
